- The meet must adhere to the *Rules that Govern YMCA Competitive Sports*.
- USA Swimming Technical Rules must be used.
- Certified and current YMCA Swim Officials will conduct the meet.
- Only coaches with current CPR, First Aid and Lifeguard/YASA/Safety Training for Swim Coaches certifications will be permitted on deck.
- All swimmers must be full privilege members of their YMCA and must have represented only their YMCA in competition (high school excepted) for a period of 90 days prior to the start of the meet.
- The meet must have entry standards.
- The meet must be: the highest level championship meet for a given region, an end-of-season meet at a higher level for a given region, or an invitational that includes competitors from multiple regions and with a level of competition higher than that offered in their region.
